TERM AND CONDITIONS

Refund Policy:

Since appointments are typically made a week in advance, cancellations or rescheduling of sessions is allowed with a 24-hour period.

Any cancellations/rescheduling/ missed appointments occurring without a 24 hour notice will be fully charged for.

In case of emergencies and in one off cases, you could reach out to your therapist and let them know. The discretion to waive of the cancellation fee would lie with the individual therapist.

1.2.2 Appointments (Audio/Video/Face to Face):

1.2.2.1 For any services purchased, The Mind Garden team shall make 2 attempts to reach the customer for confirmation of the services. In case, the customer fails to respond within 7 days of the last communication, the service will be treated as consumed and no refunds shall be provided by The Mind Garden.

- 1.2.2.2 In case, of technical difficulties during or at the time of the session, The Mind Garden will check with their service providers. If the case is adjudged to be genuine, the appointment shall be rescheduled.
- 1.2.2.3 For Audio/Video Sessions, in case, the customer fails to turn up at the time of the appointment, appointment will be treated as consumed and no refunds shall be provided by The Mind Garden.

For Face to Face appointments, any no shows are treated as availed services and no refund or rescheduling shall be provided by The Mind Garden in such a scenario.

15. MISCELLANEOUS PROVISIONS

15.1 Survival: In the event of termination or expiration of these Terms for any reason, any provisions of these Terms that by their nature should survive termination of these Terms will survive termination of these Terms, unless contrary to the pertinent provisions herein stated.
